Do we use so-called COOKIES on our website? And what is it actually?

A cookie is a small text file that is stored locally in your web browser when you visit our websites, including our e-shop (applies to registered users). We use them to customize the operation of our websites to your needs, as well as to analyse their use. They do not include any personal data and it is not possible to identify you through them on third-party websites - including the sites of analysis providers.

We use the following cookies on our website:

- **strictly necessary cookies** - these files are necessary to ensure the functionality of the website and cannot be disabled in our systems. They are usually set only as a reaction to your actions, which represent a request related to services, such as setting privacy preferences, logging in or filling out forms. You can set your browser to block or warn you about these cookies, but in that case, some parts of the site may not function;

cookie_consent_status	Stores information on whether the user has consented to the processing of cookies.	1 month
CurrentDomain	Stores information about the current domain or language version of the website to ensure correct loading of content.	Session
CurrentLanguage	Stores the user's preferred language for reloading the page in the correct version.	Session
18n_redirected	Prevents repeated redirection of the user to the language version they have already selected.	1 year

How long do we process cookies?

Strictly necessary cookies – exclusively for the period necessary to ensure the functionality of the website.

Cookies management

If you have given us consent to the use of cookies, this consent can be withdrawn in accordance with the GDPR.
